Sub: 3<sup>rd</sup> IGST Special Refund Fortnight Drive from 16<sup>th</sup> July to 31<sup>st</sup> July, 2018 – Reg.

1. Attention of Exporters/Custom Brokers/Steamer Agents/Other Stakeholders and the Trading Public is invited to the Press release issued by CBIC dated 16.07.2018. The CBIC has already observed two special IGST Refund Drives in the month of March, 2018 (15<sup>th</sup> to 31<sup>st</sup> March) and June, 2018 (31<sup>st</sup> May to 16<sup>th</sup> June). Now the 3<sup>rd</sup> Fortnight IGST Refund Drive is being organized from 16.07.2018 to 31.07.2018 wherein efforts will be made to dispose of all the pending IGST refund claims in respect of Shipping Bills filed prior to 15<sup>th</sup> June, 2018 and where GSTN has transmitted records to Customs EDI system.
2. In this regard, reference is made to the Chennai Customs (Air) Facility Circular No. 02/2018 dated 15.03.2018, Chennai Customs (Air) Facility Circular No. 03/2018 dated 30.05.2018 issued during the 1<sup>st</sup> and the 2<sup>nd</sup> Special Refund Fortnight Drive respectively and the Public Notices issued by the Commissioner of Customs, Chennai-VII Commissionerate (Air) vide i) Public Notice No.21/2017 dated 13.10.2017, ii) Public Notice No.23/2017 dated 08.11.2017, iii) Public Notice No.29/2017 dated 01.12.2017, iv) Public Notice No.11/2018 dated 26.02.2018, v) Public Notice No.12/2018 dated 15.03.2018, vi) Public Notice No.13/2018 dated 15.03.2018, vii) Public Notice No.20/2018 dated 30.05.2018, viii) Public Notice No.21/2018 dated 30.05.2018 and ix) Public Notice No.23/2018 dated 08.06.2018.
