Subject: ICES Advisory 14/2022 - Streamlining of Alerts and Suspension Roles in Exports – reg.

\*\*\*\*\*\*

Attention of all the officers and staff is invited to the ICES Advisory No. 14/2022 dated 29.09.2022, wherein the detailed procedure for streamlining the Alerts and Suspension Roles in Exports were provided. Reference may also be made to ICES Advisory No. 22/2020 (both advisories are available in Antarang Portal), wherein for streamlining the system of placing alert and suspension mechanism in ICES a single role by the name EXP\_ALT has been created for insertion of all exports related alerts and suspensions. Further, to ensure a two-level check, the options to revoke these alerts/suspensions have been moved to ADDL role which should be allocated only to an officer of the rank of ADC/JC.

Hence, EXP\_ALT role shall be allotted to DC/AC who are supervising the disbursal of export incentives viz., Drawback, IGST, RoDTEP, RoSCTL etc., to place the alerts and ADDL role shall be allotted to ADC/JC who are supervising the disbursal of export incentives. Accordingly, the ADC/JC in charge of supervising disbursal of Export Incentives viz., Drawback, IGST, RoDTEP, RoSCTL etc., shall be the proper officer for revocation of alerts, as the case may be.
