Reference is made to this office letter dated 23.12.2023 on the above mentioned subject. In this regard, it is informed that e-Auction No.48 is scheduled to be conducted on 02.02.2024 in order to dispose the uncleared / unclaimed Import cargo that arrived for the period up to June 2023. Accordingly, the said cargo were forwarded to the government approved valuer for Inventorisation and valuation, final notices were also issued to the concerned Importers / CHA / Airlines to clear the consignments as per Section 48 of Indian Customs Act, 1962.


During Inventorisation, the approved valuer M/s. Superintendence Company of India (P) Ltd., segregated the inventorised cargo as saleable and non-saleable items. The saleable items were processed for placing in said e-Auction No.48. Accordingly, Stickered list, Lot list, Category List, Valuation list of these saleable cargo received from the approved valuer were already submitted to Customs (UCC) along with copies of final notices vide this office letter referred above for further necessary action at your end.

Hence, it is requested that Customs (UCC) may carry out examination and issue approval /NOC for these consignments to be placed in the proposed e-Auction No.48 and enable this office to submit a final lot list of E-Auction No.48 for final NOC / approval.

In view of above, it is also requested that necessary approval / NOC may kindly be accorded to conduct e-Auction No.48 scheduled to be held on 02.02.2024 with date of display on 01.02.2024 as per the guidelines stipulated in the CBIC Circular No.49/2018 dated 03.12.2018 of Customs Department.
