Sub: Notice inviting tenders for Quotations from scrap vendors w.r.t. 35 Time Expired bonds as Scrap- Reg.

Sealed tenders for Quotations are hereby invited from scrap vendors, individuals for the purchase and removal of scrap materials consisting of bearings, thermo element, welded tube, transistor, yarn detector etc. lying at CWC, Virugambakkam (public bonded warehouse).

Description of Scrap Material:

The scrap material consists of bearings, thermo element, welded tube, transistor, yarn detector etc. The estimated quantity of each type of scrap is as per the Annexure-A attached herewith.

Requirements for Scrap Vendors:

- Valid licenses for scrap processing and transportation in accordance with local regulations.
- Experience in handling similar types of scrap material.
- Capability for safe and efficient removal of scrap material from the warehouse.

Instruction to the tenderers:

1. The tender should be submitted in Standard Form of Tender 'Form -21"

- attached in annexure, in sealed cover super-scribed as "Sale of Scraps" along with EMD declaration documents.
- 2. The Tender shall be submitted along with the Earnest Money Deposit (EMD) in the form of Demand Draft of Rs. 1500/- in favour of The Commissioner of Customs, ACC, Meenambakkam.
- 3. The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of tenderer on all the pages.
- 4. The tenderers are free to inspect the Scrap goods at the address of CWC Virugambakkam, No.1, New No. 105, Arcot Road, Virugambakkam, Chennai-600092, on any working day from 28.03.2023 to 10.04.2023 in the presence of CWC Virugambakkm officials.
- 5. Last date of submission of Tender is on 12.04.2024 at 1700 Hrs.
- 6. Date and Time of opening of Tender is on 13.04.2024 at 1200 Hrs.
- 7. The tender shall be awarded based on the highest offer received.

Procedure for Disposal of Scrap

- The successful bidder shall deposit the total lump sum amount in Rupees by way
 of Demand Draft in favour of "Commissioner of Customs, Air Cargo
 Commissionerate, Meenambakkam" payable at Chennai towards the cost of
 Scrap w.r.t 35 TBBs within three working days from the date of awarding the
 order.
- The truck/tempo for scrap lifting and carrying shall be arranged by tenderer at their own cost. The tender shall have to make arrangement for loading of scrap to truck/tempo at their own cost.
